Business Day means any day Monday through Friday, provided that the weekday is not on a federal holiday. When a federal holiday falls on a Sunday, the next Monday is not a Business Day.

Statement Cycle means the period of time for which BAC provides a summary of the financial activities and transactions that post and settle to the accountholder's account. It is also used to determine the Diamond Rewards Saver account's monthly service charge. The Statement Cycle ends on the last Business Day of the month. The Statement Cycle begins on the first calendar day following the last Business Day of the month.

Monthly Qualification Cycle is a period of time used for determining rewards eligibility and the Diamond Rewards checking account's monthly service charge. This period ends one Business Day prior to the close of the current Statement Cycle with a new Monthly Qualification Cycle beginning the next calendar day.
