# 1. Tax Payment Template Overview

With Cash Management, you can pay your business taxes quickly and easily using a Tax Payment Funds Transfer Template. Tax payment templates are accessed by selecting Transfer List from the Funds Management menu. If you do not have a tax payment template on your transfer list you can create one by selecting Add Funds Transfer Template from the Administration menu.

#### 1a. Creating a Tax Payment Template

- From the Administration drop-down menu, select Add Template.
- Select "Tax Payment" as the type of fund transfer template from the drop-down box.
- Click Submit
- Complete the template fields according to the type of tax payment being generated (sections 2-5 of this guide detail the field data required for most Federal and State of California tax types)
  - The Routing/Transit number and Account number must be provided by the Tax Agency.

Contact BAC to request access to the newly created Tax Template.

#### 1b. Completing an Existing Tax Payment Template

- From the Management Tools drop-down menu, select Transfer List.
- Click on the name of the tax payment template you would like to use.
- Verify the Transfer Information listed on the left
- Complete the Issue Transfer information on the right
- Click Submit

## Tax Payment Approval

If your administrator has defined an approval process for the template you are using to issue a tax payment, a statement indicating the tax payment is pending approval is displayed upon submission. Employees assigned approval rights can review tax payments waiting for approval by accessing the Review menu (you cannot approve tax payments you have created).

## 2. Federal Tax Payments

#### 2a. The Electronic Federal Tax Payment System (EFTPS)

If you enroll in the Electronic Federal Tax Payment System (EFTPS) at <u>http://www.eftps.gov</u> you will be able to check your federal tax payments or access your payment history for payments initiated thru Cash Management. When you enroll be sure to select "EFTPS-Through a Financial Institution" on your enrollment form. You will receive a PIN and Internet Password which you will enter at the EFTPS site to check your payment history online.


#### 2b. Creating a Federal Tax Payment Template

- From the Administration drop-down menu, select Add Template.
- Select "Tax Payment" as the type of fund transfer template from the drop-down box.
- Click Submit

#### 3a. Employment Development Department (EDD) Tax Payments

Electronic Funds Transfer (EFT) is an electronic method for making all of your Unemployment Insurance (UI), Employment Training Tax (ETT), State Disability Insurance (SDI), and Personal Income Tax (PIT) payments. Funds are transferred from your bank account to the State's bank account, eliminating the need to send a coupon and a check/money order. To register for EFT, complete the *EFT Authorization Agreement* (DE 26) and submit to the EFT Unit of the EDD department.

#### 4a. Franchise Tax Board (FTB) Tax Payments

Electronic Funds Transfer (EFT) is an electronic method for making all of your Franchise Tax Board (FTB) payments. Funds are transferred from your bank account to the State's bank account, eliminating the need to send a coupon and a check/money order. To receive approval to submit FTB payments using EFT, the Authorization Agreement for Electronic Funds Transfer (FTB 3815) must be completed and returned to FTB.

Electronic Funds Transfer (EFT) is an electronic method for making all of your State Board of Equalization (BOE) payments. Funds are transferred from your bank account to the State's bank account, eliminating the need to send a coupon and a check/money order. To receive approval to submit BOE payments using EFT, the Authorization Agreement for Electronic Funds Transfer (BOE-555-EFT) must be submitted to BOE and once it is reviewed, you will be sent a letter confirming your EFT start date.
